AMENDMENT OF REGISTRATION OF SANTS PRIVATE HIGHER EDUCATION INSTITUTION (PTY) LTD/SANTS PRIVATE HIGHER EDUCATION AS A PRIVATE HIGHER EDUCATION INSTITUTION (PHEI FILE NO.: 15/3/1/1/257)

SANTS Private Higher Education Institution (Pty) Ltd/SANTS Private Higher Education was scheduled for a review for re-accreditation by the Higher Education Quality Committee (HEQC) of the Council on Higher Education (CHE) [HEQC (CHE)] since its registration cycle is due to expire on 31 December 2026. The accreditation review will not be finalised by 31 December 2026. In order to accommodate the finalisation of the review, the duration of your institution's registration cycle is being extended from 01 January 2027 to 31 December 2028.

Accordingly, the registration of SANTS Private Higher Education Institution (Pty) Ltd/SANTS Private Higher Education is amended in terms of sections 60, 61 and 63 of the Higher Education Act, 1997 (Act No. 101 of 1997, as amended) (the Act) as follows:

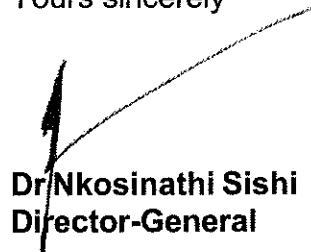

In accordance with Regulation 20(3), the Institution must within 14 days return the previous certificate of registration to the Directorate.
